For simplicity, individuals are designed by letter. "O" represents the original owner, i.e., the grantor, and the letters A, B, C, etc. represent the grantees. Assume that all relevant individuals are living unless the problem expressly states otherwise. If a problem appears to lack sufficient information to answer the question, make alternative assumptions and answer under each assumption.
